



### Step 1:

IMGs submit their medical degree (final medical diploma/primary medical qualification) in clinical medicine and surgery for Primary Source Verification (PSV). It is important to determine whether your medical school as well as your degree title and graduation year are [eligible](#). Verification of an Australian or New Zealand medical degree—verification is not required.



### Step 2:

- > Create a [MyIntealth](#) account and portfolio.
- > When advised by ECFMG, upload your eligible medical degree (final medical diploma/primary medical qualification) and/or postgraduate credential(s) and/or specialist qualification(s) to your MyIntealth account. Ensure that you nominate the AMC to receive the outsource notification and verification report.
- > Also refer to ECFMGs [Special Instructions for Physicians Applying to Practice in Australia](#) for important notes on credentials verified through MyIntealth.



Your MyIntealth ID should be confirmed within 3 business days. **Your MyIntealth ID is required to proceed with Step 3.**



### Step 3:

Create an AMC account and establish an [initial portfolio](#) (only if applicable).  
*You will need your MyIntealth ID to complete the initial portfolio and/or additional qualification applications.*

### Step 4:

Submit your eligible medical degree (final medical diploma/primary medical qualification) and/or eligible postgraduate credential(s) and/or specialist qualification(s) (if not already done in Step 2). See the list of eligible credential types for each pathway below.



#### Standard pathway

(PSV, AMC examinations and assessments – AMC certificate) for general registration and

#### Competent authority pathway

(PSV, No AMC examinations and assessments - no AMC certificate) for general registration –

Submit for verification: **medical degree (final medical diploma)**. *This does not apply to Australian or New Zealand medical degrees.*



### Step 5:

Use their Registration self-assessment tool and proceed with your eligible assessment [pathway](#) to registration.



For the following pathways (PSV, no AMC assessment):

- **specialist pathway** - includes specialist recognition and specialist area of need
- **expedited specialist pathway**
- **short term training in a medical specialty pathway**

Submit for verification:

- > **Medical degree (final medical diploma)**. *This does not apply to Australian or New Zealand medical degrees.*
- > **Eligible postgraduate credential(s) and/or specialist qualification(s)**. *This does not apply to Australian/Australasian postgraduate credential(s)/specialist qualification(s).*

For the specialist pathway and short term training in a medical specialty pathway – *check with the relevant Australian/Australasian [specialist medical college\(s\)](#) for advice on which of your qualification(s) you need to submit for verification through ECFMG and add to your AMC account.*

For the expedited specialist pathway – *check on the Medical Board of Australia's - [Expedited specialist pathway: accepted qualification list](#) to confirm the list of pre-approved specialist qualifications that you need to submit for verification through ECFMG and add to your AMC account.*



### Step 6:

- > Ensure that the AMC is nominated to receive the outsource notification(s) and/or verification report(s) from ECFMG to update your verification status(es) on your [AMC account](#).
- > To view the verification status(es) in your AMC account, select the 'See qualifications' option on your landing page.
- > *The Medical Board of Australia/Ahpra and the nominated Australian/Australasian specialist medical college(s)(if applicable) will have access to view your verification and qualification information, AMC certificate and specialist assessment outcome (uploaded by your nominated specialist medical college, if applicable) via the AMC portal.*
