Appointment of a Member of a State or Territory Board of the Medical Board of Australia or a member of a medical council of a State or Territory of Australia

The Australian Medical Council Limited (AMC) is an independent national standards body for medical education and training. The AMC's purpose is to ensure that standards of education, training and assessment of the medical profession promote and protect the health of the Australian community. The AMC also accredits medical schools in Aotearoa, New Zealand, and Australasian medical colleges.

The AMC is a company limited by guarantee and a registered charity. It operates in accordance with the *Corporations Act 2001 (Cth)*, the *Australian Charities and Not-for-profits Commission Act 2012 (Cth)* and the AMC Constitution.

Opportunity

The AMC is seeking expressions of interest from suitably qualified individuals to be appointed as a Member of the Australian Medical Council Limited. To be eligible, applicants must, at the time of appointment:

- be a member of a State or Territory Board of the Medical Board of Australia *or* a member of a State or Territory medical council; and
- be registered under Part 7 of the *Health Practitioner Regulation National Law* by the Medical Board of Australia.

Note: the appointed Member will be one of two appointed Members who fulfil the above eligibility requirements. Appointed Members are Members of a Company Limited by Guarantee and do not represent the MBA.

Governance Context and Role of Members

The AMC is currently undertaking a Governance and Constitution Review. This review considers the role, responsibilities, and composition of Members of AMC Limited to ensure the governance framework remains fit for purpose, contemporary, and aligned with the AMC's strategic objectives.

Prior to the Governance and Constitution Review outcomes being finalised, Members will continue to be appointed in accordance with the existing AMC Constitution and relevant legislative requirements and exercise the rights and responsibilities of Members of a company limited by guarantee. Members contribute to the governance of the AMC through participation in General Meetings, which include consideration of matters reserved for Members outlined under the Constitution.

Term and Time Commitment

The Member appointment is for a term of up to four years, effective from the date of appointment.

Members are required to commit several days per year to prepare for and attend the AMC General Meeting (mid-year) and the Annual General Meeting (November). In 2026, additional Member meetings have been

scheduled to support the Governance and Constitution Review. These are scheduled for 24–25 March in Melbourne, 30–31 July in Queensland (location TBD), and 20 November in Canberra.

Skills, Experience and Attributes

The AMC is seeking candidates who can demonstrate:

- experience in medical regulation, health professional standards, education or training;
- an understanding of accreditation, quality assurance or regulatory systems;
- sound judgement, integrity and the ability to consider issues in the public interest; and
- alignment with the AMC’s purpose and values.

The AMC is committed to diversity in its governance and encourages applications from individuals with diverse backgrounds, perspectives and lived experiences. Consistent with its strategic commitment to culturally safe practice, the AMC strongly encourages applications from Aboriginal and/or Torres Strait Islander and Māori Peoples.

Selection Process

Applications will be assessed by an AMC Selection Panel. Shortlisted candidates may be invited to participate in an interview (by video conference).

A recommendation will be made to the AMC Directors, with appointments confirmed in accordance with the AMC Constitution.

To apply, candidates are required to:

1. Complete the AMC **Member Expression of Interest Form**; and
2. Provide a current curriculum vitae (PDF).
